NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and to induce the Owner(s) and AECOM Tishman to give me permission to be allowed on the Premises, to the maximum extent permitted by law, I, for myself, my heirs, my executors, my administrators, my successors and/or my assigns (collectively and individually, the "Releasors"), hereby: (1) assume all the risks and hazards attendant upon my entry on and my presence at the Premises; (2) release the Owners, AECOM Tishman, AECOM Tishman's and/or the Owners' subcontractors of any tier, and all officers, employees, agents, personal representatives, parents, subsidiaries, affiliates, successors and assigns of the foregoing parties (collectively and individually, the "Releasees") from and against any and all actions, causes of action, suits, claims, rights, damages, losses, expenses or demands of any kind or nature whatsoever, which I or the Releasors can or might have as a result of or arising out of my presence on or about the Premises, including, but not limited to, claims for any sickness or illness, personal injury or death, which I, the Releasors or any person on the Premises under this permission may suffer or sustain; and (3) agree to indemnify and hold harmless the Releasees of, from and against any and/or all loss, costs, claims, suits, damages and judgments (including attorney's fees and disbursements) of any kind or nature whatsoever, however caused, including, but not limited to, those for property damage and bodily injury, including death, arising out of or in connection with my presence on or about the Premises.

FURTHERMORE, I also agree that for consideration of being granted permission to be allowed on the premises, I: (a) shall use my best efforts (but in any event not less than those employed for safeguarding my own proprietary information) to not disclose or share information learned on this visit and keep it confidential, such information includes but is not limited to: data, know-how, trade secrets, inventions, end use product applications, product specifications and

designs, performance characteristics, formulations, materials, experimental and test data, processes, methods of manufacture and equipment ("Confidential Information"); (b) shall not take any photos at the Premises, and shall not share anything online, in social media, or make public any information learned regarding, or photos of, the Premises or project site; (c) shall not, communicate such Confidential Information and/or knowledge to any third party, (d) shall not utilize the Confidential Information.

FURTHERMORE, this agreement and any action related thereto will be governed and interpreted by and under the laws of the State of New Jersey, without giving effect to any conflicts of laws principles that require the application of the law of a different state. By signing below, you hereby expressly consent to personal jurisdiction and venue in the state and federal courts of New Jersey in connection with any disputes arising out of this agreement.
